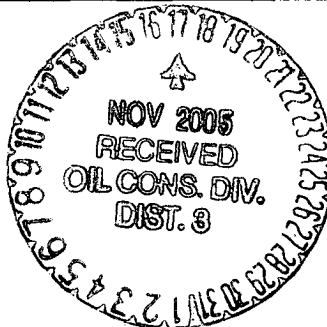

Circ. hole w/ air & mist, TIH w/ underreamer, underream open hole to TD @ 3226'. POOH w/ underreamer. Natural & Energized surges for 12 days. TIH w/ 6-1/4" bit, circ. clean, COUT TD, surge 2 days. TIH w/ pre-perfed 5-1/2" 15.5#, J-55, LT&C liner & set liner @ 3226' w/ TOL @ 2985' (27' overlap into 7" shoe). Perf plug intervals from 3029' - 3159', circ. hole. TIH w/ 2-3/8" 4.7#, J-55, EUE tubing (101 jts) and landed @ 3207', SN @ 3183'. ND BOP & NU WH, RU rod & pump equipment on 11/10/05, spaced out. Load tbg & test to 500 psi. RD & released rig on 11/10/05.
