For the portion of work occurring after the December 1<sup>st</sup> closure date the following will be observed:

- 1) Sound walls will be erected around the compressor package.
- 2) Daylight hours of operation will be observed & conducted Monday thru Friday.
- 3) Crews will travel together & traffic will be kept to a minimum.
- 4) Aztec rig #656 will be utilized for this work.
- 5) If excessively muddy conditions occur, work will suspend until dry enough conditions return.
