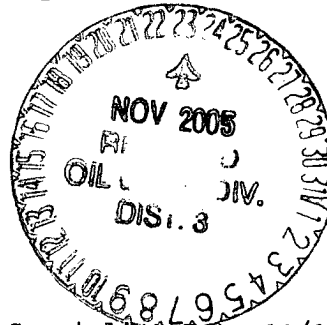

Cmt w/59 sxs Type I-II cmt (95 CF-16 bbl slurry) w/20% Fly Ash. Drop Plug and displace with 9 bbl H2O. Circ 3 bbls cmt to surface. RD. WOC. The casing will be PT with the drilling rig before proceeding with drilling.
