Drilled 8-3/4" hole. TIH w/68 jts 7", 20#, J-55, ST&C csg to 2880'. Cmt'd csg w/375 sx Type III cmt w/1% CaCl₂, 1/4 pps celloflake, 8% gel, & 2% phenoseal (11.9 ppg & 2.62 cuft/sx) followed by 100 sx type III cmt w/1% CaCl₂, 1/4 pps celloflake & 2% phenoseal (14.5 ppg & 1.41 cuft/sx).
