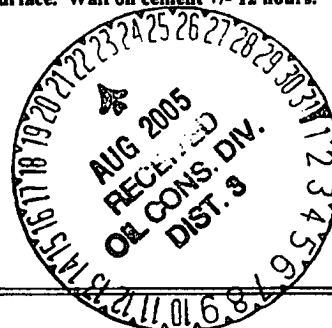

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. We drilled 8 3/4" hole to 3102', and ran 7", 23#, J-55, R-3 New API 5 CT LTC Casing, landed @ 3101.00' KB (KB=5'0"). Cemented casing on 8/15/05 with 532 sks Premium Lite FM lead Cement, plus 3% CACL2 plus 0.25 lb/sk Celloflake, plus 5 lb/sk LCM-1, plus 0.4% FL FL-S2, plus 8% Bentonite, plus 0.4% Sodium Metasilicates, yield 2.13, 1133.16 cu. ft. Followed with 95 sks Type 3 tall Cement with 1% CaCl, plus 0.25 lb/sk Celloflake, plus 0.2% FL-S2, yield 1.38, 131.10 cu.ft. We used 3 centralizers on the bottom 3 joints every 400' thereafter. We ran turbolizers at base of the Ojo and 1 joint into the Ojo. Circulated 84 bbls of good cement to surface. Wait on cement +/- 12 hours.
