XTO Energy Inc. requests approval for exception to Rule 303-C to permit DHC of production from the Basin Dakota (71599) and the Blanco Mesaverde (72319). XTO Energy proposes to downhole commingle this well upon completion.

Allocations are based upon a 9-section EUR from the Stanolind A #2F & Stanolind A #2E which are both Dakota/Mesaverde DHC's in the same section and proration unit as this well:

Mesaverde	Gas 51%	Oil 26%	Water 50%
Dakota	Gas 49%	Oil 74%	Water 50%

Both pools are included in the NMOC preapproved pool combinations for DHC in the SJ Basin. Working interest, net royalty interest and overriding royalty interest owners have been notified by certified, return receipt mail on November 7, 2005. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
