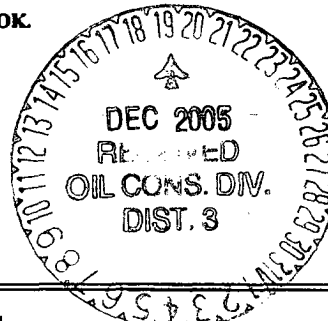

Ran centralizers on 1st, 2nd, and 3rd joints including shoe joint. Cemented with 110, Type III 2% CaCl₂, .25 #/SK D29, 2% D46 Inti-Foamer, Class C, 1.33 Yield, 14.8 Density. Circulated 17 bbls cement to surface. WOC 12 hrs.

10/25/05 - Pressure tested 9-5/8" casing to 1000 psi for 30 mins. Held OK.
