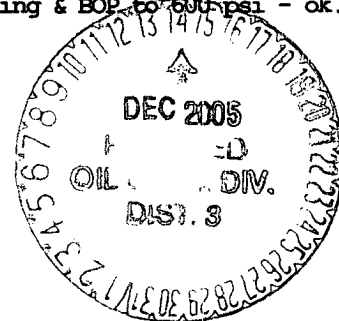

12/03/05 Spud well @ 12:00 am on 12/03/05. Drill 12-1/4" hole to 340'. Run 7 jts. 8.625" 24# J-55 ST&C casing, set @ 333'. RU Halliburton. Cement with 325 sks Class B, 2% CaCl2, 1/4#/sk floccle (384 cu.ft.). Plug down @ 12:30 am on 12/04/05. Did not circulate cement to surface. Pick up 1" and tag cement @ 41'. Top job surface with 100 sks Class B, 2% CaCl2, 1/4#/sk floccle (118 cu.ft.). Circulate 3 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
