10/04/05 MIRU. Kill well and TOH with 2.375" tubing. TIH and set 7" packer @ 2400'. Pressure test casing to 2500 psi - ok.

10/05/05 Release packer and TOH. Re-perforate Fruitland Coal from 2448-50', 2503-06', 2514-16', 2518-23', 2525-28', 2546-50' with 76 holes, 0.43". TIH with 7" RITS packer and set @ 2347'. Acidize with 2000 gallons 15% HCL and 200 - 1.1 SG ball-sealers. Unseat packer, TIH and knock balls off of perforations. TOH laying down 7" packer.

10/06/05 RU Stinger wellhead isolation tool. Refrac the Fruitland Coal from 2448'-2550' with 83,000 gals 70Q foam 20# linear gel, 10,000# 40/70 sand & 80,000# 20/40 sand at a maximum concentration of 4.8 ppg. RD wellhead isolation tool. Flow back frac.

10/07-11/05 Flow back frac and clean out to PBID @ 2575'.

10/12/05 Landed 2.375' tubing @ 2542'. Returned well to production.
