Cmt w/59 sxs Type I-II with 20% Fly Ash cmt (95 CF-16 bbl slurry). Drop plug and displace using rig pump. No cmt to surface. WOC. RD.

12/16/05 Install 3/4" PVC to tag cement. Tag cmt @ 21'. Pump 6 sxs Type I-II Neat cmt (8 CF) to bring to surface. Circ 1/4 bbl cmt to surface.

Casing will be PT with the drilling rig before proceeding with drilling.
