BP America submitted Application for Permit to Drill the subject well on 03/02/05. The APD was approved on 08/25/05.

BP America respectfully requests permission to change the depth of the intermediate string (7") casing from 2945' to 4498'. The purpose of this deeper setting is to protect the air drilled 6 1/4" section from water influx from the wet Cliffhouse formation in this area. The 7" string consists of 20# J-55 STC from 0' - 4000' MD and 23# N-80 LTC below 4000' MD.

Adjust cement volume to ensure circulation to surface.
