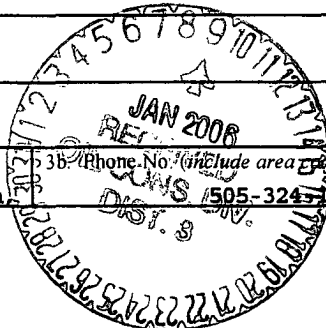

Follow by pprox 50 sx 50/50 Class B Poz w/2% gel, 1/4#/sx Flocele, 0.5% Halad -9 (yield = 1.38) w/slurry wt of 13.5#/gal & open hole excess factor of +/- 100%.

REVISED PROD PLAN: Hole size 7-7/8", csg size 5-1/2", 15.5#, J-55, ST&C csg. Cmt w/approx 246 sx Class B light cmt (65% cmt/35% Poz w/6% gel) w/5#/sx Gilsonite, 1/4#/sx Flocele (yield=1.99 cuft/sx) w/slurry wt of 12.4#/gal & open hole excess factor +/- 100%. Tail slurry approx 85 sx 50/50 Class B Poz w/2% gel, 1/4#/sx Flocele, 0.5% Halad -9 (yield = 1.38) with slurry wt of 13.5#/gal & open hole excess factor of +/- 100%.
