

- On 7-5-1988 a CIBP was set @ 7,950' w a dump bailer load of cement in the amount of 5 sx Class B on top.
- On 7-5-88 the DV tool at 3,274' was found to be leaking and a 50 sack plug Class B w/ 2% CaCl2 was spotted and across the DV tool and allowed to set up. The plug was then tested to 4,000 psig for 30 minutes and held. The plug was drilled out to about 3,207' and the FRC was then completed from 3,080' to 3,137'.

Note: The only zone on production since summer of 1988 is the Fruitland Coal as the Dakota has been abandoned.
