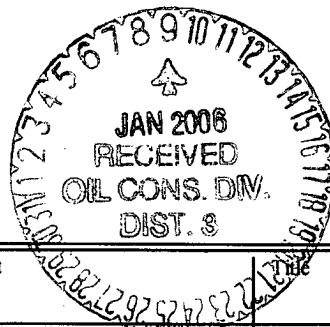

Cmtd prod csg w/411 sx type III/POZ/Gel cmt w/2% CaCl₂, 0.2% dispersant, 0.2% fl & 1/4 pps cello (12.5 ppg & 2.01 cuft/sx) followed by 150 sx type III cmt w/5% bonding additive, 2% LCM & 1/4 pps cello (14.2 ppg & 1.54 cuft/sx). Circ 55 bbls cmt to surf. Cmtd 2nd stage w/435 sx type III cmt 2/8% gel, 2% LCM & 1/4 pps cello (11.9 ppg & 2.54 cuft/sx) followed by 100 sx type III cmt (14.5 ppg & 1.39 cuft/sx). Circ 105 bbls cmt to surf.

Pressure tested production casing to 1000 psig for 15 minutes. Tested OK.
