No cmt circ to surf.

Cmtd 2nd stage w/430 sx 65/35 Std Poz cmt w/6% gel, 5 pps gilsonite & 1/4 pps flocele (11.8 ppg & 2.31 cuft/sx) followed by 100 sx type III cmt (14.5 ppg & 1.38 cuft/sx).

Pressure tested 5-1/2" production casing to 1500 psig for 5 minutes on 12/17/05. Tested OK.
