On December 15, 2005, Operator, Lance Oil & Gas Company, Inc., set a bridge plug at the top of the Harper Hill Pictured Cliffs formation, at 889' KB, thereby temporarily plugging back the Harper Hill Pictured Cliffs formation. Completion operations then commenced on the Basal Fruitland Coal (S-8) formation. The Basal Fruitland Coal (S-8) was perforated and frac'd from 865' - 886' KB with 27,300 gals Delta 140 with SandWedge NT containing 73,200 lbs of 16 / 30 Brady sand.

Operator wishes to produce the Basal Fruitland Coal (S-8) zone only of this well for a period of time in order to establish production rate in the Basal Fruitland Coal (S-8) zone.

Operator will request to downhole commingle prior to pulling the Bridge Plug set at 889' KB and producing the Basal Fruitland Coal (S-8) and Harper Hill Pictured Cliffs zones together.
