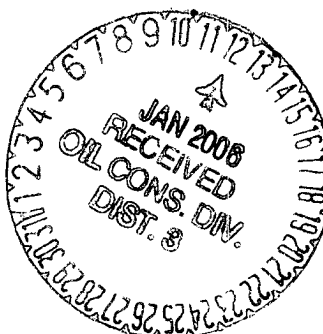

Plug down @ 9:30 pm on 12/27/05. Circulate 15 bbls cement to surface. WOC. NU BOP. Test casing & BOP to 600 psi - ok.
