Pumped preflush of 10 bbls water/10 bbls mud clean/10 bbls water ahead of 19 sx (56 cf - 10 bbls) scavenger cement Type III then Lead w/141 sx (300 cf - 53 bbl slurry) Premium Lite w/3% CaCl₂, 1/4#/sx Celloflake, 5#/sx LCM 1, 0.4% FL-52, 0.4% SMS. 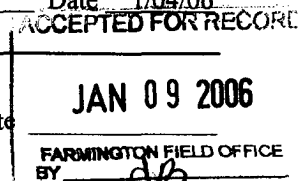
