(56 cf - 10 bbls) Type III. Then cemented lead w/ 137 sx (292 cf - 52 bbls slurry) Premium Lite Type III w/ 3% CaCl, .25 #/sx Cello-Flake, 5 #/sx LCM-1, .40% FI-52, .40% SMS.
