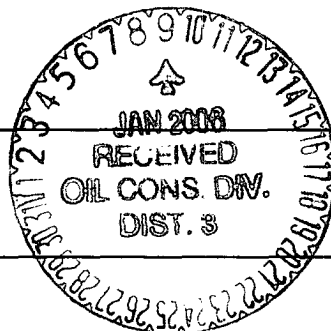

1. MIRU completion rig. TOOH with tubing.
2. TIH with RBP on tubing and set +/- 2400'.
3. Pressure test casing to 3500 psi for 15 minutes.
4. Perforate and fracture stimulate the Fruitland Coal/Sand formations.
5. Flow back well. Clean out as required to PBTD.
6. Land tubing as a Fruitland Coal/Sand commingle producer.
7. RDMO rig. Return well to production.


