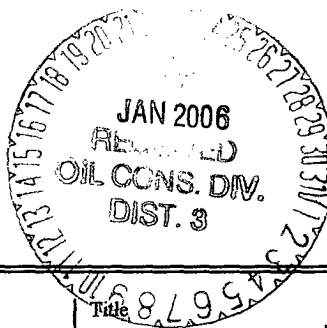

Elm Ridge Exploration Co, LLC spud this well on 1-10-06. We drilled a 12-1/4" hole to 147'. Ran 8 5/8" 24# J-55 casing to 142'. Pumped 115 sks of STD cement. Circulated cement to surface w/ 8 bbls excess. Pressure tested well to 1500 PSI.
