- 3) MIRU acid equip. Acidz Lwr DK perfs fr/6748'-6765' w/+/- 1000 gals 15% NEFE HCl acid. Recrd ISIP 5, 10 & 15 min. RDMO acid trks.
- 4) NOTE: Will not install isol tool until CO2 frac. Lwr & Upper DK acid jobs to be done thru frac vlv.
- 5) Frac Lwr DK perfs w/approx 25,000 gals Delta 200 XL frac fluid w/26,000# sd. Max TP @ 4000 psig.
- 6) Set composite BP @ approx 6730'.
- 7) Perf Upper DK fr/6606'-6707' w/approx 24 - 0.34" dia holes.
- 8) Acidz Upper DK perfs fr/6606'-6707' w/+/- 1000 gals 15% NEFE HCl acid. Record ISIP @ 5, 10 & 15 min.
- 9) Install WH isolation tool. Frac Upper Dk perfs w/approx 63,000 gals 70Q CO2 Purgel III LT CO2 foam frac fluid w/120,000# sd. Max TP @ 4000 psig.
- 10) MIRU AFU & clean out frac sd & DO CBP @ 6730'-6882' PBTD.
- 11) Land EOT @ 6740'. Swab well until well KO. Run IP tst.
- 12) TIH w/NC, SN & 2-3./8" tbg. Land tbg: TAC @ 6500'; SN @ 6825'; EOT @ 6850'
- 13) RWIP.
