Cmt'd surf csg w/210 sx Class "B" cmt w/3% CaCl2 & 1/4 pps Celloflake (15.60 ppg). Circ 16 bbls cmt to surf. Pressure tested surf csg to 1000 psig for 30 minutes. Held OK.

XTO Energy reached drillers TD of 4987' @ 1:45 pm, 12/25/05. TIH w/124 jts 5-1/2", J-55, 15.5#, LT&C csg to 4982' KB. Cmt'd 1st stage w/440 sx Prem Lite HS cmt w/2% CaCl2, 1/2 pps Celloflake, 0.2% CD-32, 0.5% FL-52, 2% Phenoseal (12.5 ppg & 2.01 cuft/sx). CIRCULATED 30 BBLS CMT TO SURF ON 1ST STAGE. Cmt'd 2nd stage w/670 sx Type III cmt w/1/4 pps Celloflake, 8% Bentonite, 2% Phenoseal (11.9 ppg & 2.6 cuft/sx). Circ 145 bbls cmt to surf.
