Drilled 12 1/4" hole to 295' on 11/21/05, set 8 jts of 9 5/8", H-40, ST&C, 32.3# casing at 285'. Cemented w/175 sx (34 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,775' on 11/25/05, set 85 jts of 7", J-55 LT&C, 23# casing at 3,766'. Cemented lead w/485 sx (125 bbls) 50/50 POZ, Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (19 bbls) STD, 4/10% Halad 344. Good cement top is at 900' with good stringers up to 700'. Verbal verification by Jim Lavato and Adrienne Brumley for top of cement at 700' is good.. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 6,275' on 11/28/05, set 153 jts 4 1/2", J-55, LT&C, 11.6# casing at 6,263'. Cemented w/300 sx (78 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL. Top of cement for the 4 1/2" is at 775'. Landed 2 3/8" production tubing at 6,109'.
