Perforations are from 3,372' - 3,663', 4 SPF, 384 holes, 120° degree phasing. On 11/23/05 ran back in hole with 118 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,705', return well to sales on 11/25/05.
