XTO Energy Inc. proposes to remediate an earthen separator pit & assess groundwater impact from this acquired well. The earthen separator pit is the suspected source of soil & groundwater impact on this well site located on Navajo Nation surface. Phase separated hydrocarbons have been observed on the groundwater. Pit excation with offsite disposal of soil will be done, followed by installation of groundwater monitoring wells to delineate the plume & potentially recover frree phase product.
