2/8/06 MIRU Mote #1. Spud 8-3/4" hole @ 0900 2/8/06. Drilled to 141'. Circ. hole. RIH w/6 jts 7", 20#, J-55 casing and set @ 138'. Pumped preflush of 2 bbls FW, then pumped 34 sx (54 cf - 9.6 bbl slurry) of Type I-II Portland cement w/20% flyash. Dropped plug and displaced w/4.2 bbls FW. Circ. 2 bbls cement to surface. WOC. Installed WH. RD & released rig 2/8/06.

Will show casing PT on next report. The Drilling rig will conduct the PT.
