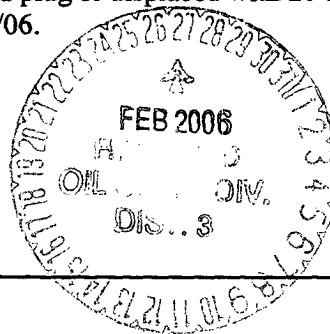

2/15/06 MIRU Mote #1 spud and drilled 12-1/4" hole @ 09:00 hrs 2/15/06. Drill ahead to 318'. Circ. hole. TIH w/ 10 jts 9-5/8", 32.3#, H-40 ST&C csg. & set @ 314'. Pumped 20 bbls H₂O ahead of 93 sx (149 cf – 26 bbls slurry) Type I-II Portland cement w/ 20% Flyash. Dropped plug & displaced with 20 bbls H₂O. Circ. 3 bbls cmnt. to surface. WOC. Install wellhead, RD on 2/16/06. Will conduct PT before drilling begins.

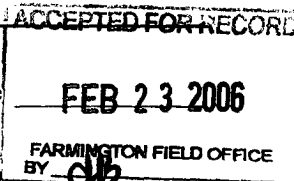
