3. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. This well produces water from the Pictured Cliffs Formations. Total daily water production is approximately 100 Bbl/day. The Basin Fruitland Coal will be completed at a later date.

The produced water is primarily transported by pipeline to a Richardson Operating Company disposal well or alternatively stored on location in an above ground storage tank. If the water is stored on location, Richardson Operating Co. trucks the water to the disposal well unless workload dictates that a third-party trucking company is needed to keep up with water. When water production exceeds the capacity of the two injection wells, water is disposed of by Key Energy Services in their disposal facility.

Richardson Operating Company operates two active salt water disposal wells in the area: Salty Dog #1 (WDW-NW/NE Sec. 1, T29N, R15W) and Salty Dog #2 (WDW-NW/SE Sec. 5, T29N, R14W).

Copies of the NMOCD Injection Orders for each injection well should be on file.
