Ran pitot test. RIH w/5 1/2" 15.5# K-55 pre-perf'd liner and set @ 3408' w/TOL @ 3045'(22' overlap into 7" shoe). Perfs @ (3112'-3150'; 3218'-3321')=141 holes. PU perf mill and milled out perf plugs. Circulate clean. RIH w/107jts 2 3/8" 4.7# J-55 tubing and set @ 3377' w/SN@ 3353'. RU to run rods. 1/26/06 RIH w/rods and pump. Spaced out. PT to 500#, ok. RD 1/26/06.

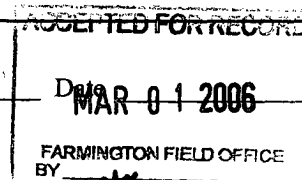
