**BP America respectfully requests permission to deepen the intermediate (8 3/4") hole from 3236' to approximately 4780' in order to case off the wet Cliffhouse sand. The 7" string consists of 20# J-55 STC from 0' - 4000' and 23# N-80 LTC below 4000'. Cement volume will be adjusted accordingly.**
