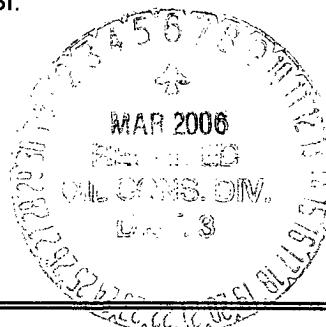

Elm Ridge Exploration Co, LLC reached a TD of 1300' on February 2, 2006. We ran 5 1/2" 15.5# J-55 LT&C casing to 1288'. Pumped 155 sks of STD cement. Tailed in w/ 110 sks of STD cement w/ 2% CACL. Circulated cement to surface w/ 22 bbls of excess. Pressure tested well to 1500 PSI.
