Elm Ridge Exploration Co, LLC spud this well on February 4, 2006. We drilled a 12 1/4" hole to 146'. We ran 3 jnts of 8 5/8" 24 # K-55 ST&C casing to 141'. Pumped 115 sks STD cement w/ 2% CACL. Circulated cement to surface w/ 7 bbls of excess. Pressure tested well to 1500 PSI.
