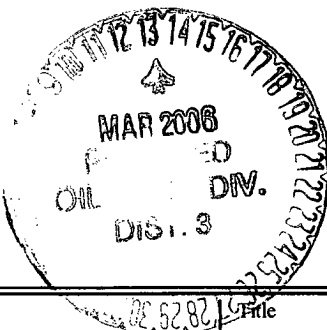

Plug down @ 2:30 pm on 03/04/06. Circulate 3 bbls cement to surface. Circulate between stages. Cement second stage with 255 sks 65/35 Class B poz, 6% gel, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk floeale tailed by 100 sks Class B, 5#/sk gilsonite, 1/4#/sk floeale (1266 cu.ft.). Plug down @ 6:30 pm on 03/05/06. Circulate 11 bbls cement to surface. Rig down @ 6:00 am on 03/06/06.
