Cement with 225 sks Class B, 2% CaCl<sub>2</sub>, 1/4#/sk floccle (265 cu.ft.). Plug down @ 4:45 pm on 02/28/06. Circulate 19 bbls cement to surface. WOC. RD Halliburton, NU BOP. Test casing & BOP to 600 psi - ok.
