Circ 10 bbls cmt to surf. Cmt'd 2nd stage w/545 sx Type III cmt w/8% bentonite, 1/4 pps celloflake & 2% phenoseal (11.9 ppg & 2.6 cuft/sx) followed by 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx).
