Southland Royalty requests a one (1) year TA status continuance on the wellbore, as per the agreed requirements with Energen Resources, to study the wellbore in hopes to return the well to production.

1. The last MIT was performed 7/16/2014 and approval received from NMOCD on 8/15/14. The casing pressure test is good for five years, at which time if the well has not been returned to production or plugged a MIT will be performed on the well.

2. Until the well is returned to production or plugged, SRC will submit a subsequent report annually requesting an approved continued TA status for the 80 ac infill.
