Mix and Pump as follows: 15 bbls of Tuned Spacer, followed by 8 bbls of 11.8 ppg scavenger, followed by 400 sxs (620 cf) of Type III w/HALAD-413, Fe-2, CFR-3, & HALAD-9. 110.4 bbls of 13.9 ppg slurry. Drop Dart & displaced w/ 132.4 bbls of treated FW. Bump plug to 875 psi. Full returns. Drop bomb. Set Liner. Circulated 26 bbls of cement to surface and had good circulation through the job. ✓
