The wellhead pressure on the Chacon Jicarilla D #9 has built up to 1100 psi due to fracing operations being conducted on Energen's Chacon Jicarilla #602H.

Energen began venting gas on the Chacon Jicarilla D #9 to a flowback tank starting on 10/16/15 in order to relieve this wellhead pressure. It is anticipated that the wellhead will need to be vented up to two times daily for 15 minutes each time until the wellhead pressure drops to 200 psi.

The wellhead pressure has been and will continue to be monitored daily, and it is anticipated that it will need to be vented daily until all plugs are drilled out on the Chacon Jicarilla #602H.

A subsequent report will be submitted once these venting operations are no longer necessary.
