The production casing will be unchanged, but the cement volumes will be increased to the following: 300 sx of lead cement containing 2% sodium metasilicate and 1/4 #/sk cello flakes followed by 100 sx of cement containing 2% CaCl and 1/4 #/sk cello flakes, for a total of 738 cf of cement.**
