
Rincon Unit #212

CONDITIONS OF APPROVAL

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
2. Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 564-7750.
3. The following modifications to your plugging program are to be made:
 - a) Bring the top of Plug #4 to 1916 ft. to cover the Kirtland and Ojo Alamo top. BLM picks top of Kirtland at 2196 ft. BLM picks top of Ojo Alamo at 1966 ft. Adjust cement volume accordingly.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.
