We are requesting surface casing depth change from 300' to 350' and hole size from 12 1/4" to 11" and casing size from 8 5/8" to 7" 23# J-55. We are also requesting the main production hole size change from 7 7/8" to 6 1/8". Surface casing will be cemented with 242 sacks of cement. Production casing will be cemented with 135 sacks of cement.


