Pumped 1000 gal prepad; frac w/29,000 gal Silverstim w/Sandwedge, 53,000# 20/40 Brady sand, & 372 gal flush. CO to PBTD w/2% KCl wtr; rec frac sand/blk wtr/gas. Swab well. Land 23 jts 2-3/8" 4.7# J-55 tbg w/NC @ 745' & SN on top btm jt @ 711'. RIH w/insert pump, 2 ea 1-1/2" sinker bars, 26 ea 3/4" rods, 1 ea 3/4" x 4' pony rod & land/seal w/polish road. Ck pump action to 600 psi, ok. Well shut in; WOPL
