





Proposed Plugging Procedure: Release packer set at 350'. TOCHW/tubing and packer. Lay down packer. TIH w/tubing. Set a 100' cement plug from 503' to 403' using 8 Sks(9.44CF) class "B" cement. Set a 100' cement plug from 315' to 215' using 8 Sks(9.44CF) class "B" cement. Set a 50' cement plug at surface, using 4 Sks(4.72CF) class "B" cement. Install an appropriate dry hole marker.
