Analytical results for the BTEX and TPH were below the regulatory standards (ND) set forth in the NMOCD Guidelines for Remediation of Leaks, Spills and Releases. Chlorides testing was conducted for information purposes and do not exceeded the NMOCD action level. No further action is needed. The final lab report is attached for your review.


