Cemented w/175 sks, 240 cu ft, Halliburton HalCem cement blend w/1% bwoc bentonite, 5 lb/sk Kol-seal, 0.125 lb/sk Pol-E-Flake, 0.1% bwoc CFR3 and 2% CaCl2 (13.5#/gal, 1.37 cu ft/sk). Total slurry for the job 240 cu ft. Displaced w/16.5 bbls fresh water. Bump plug w/230 psi. Pressured up to 875 psi. Float held ok. Circulated 18 bbls cement to surface. Job completed on 4/28/16. D&D Rig #1 released from location 4/29/16. Pressure test will be reported on completion sundry. ✓
