In response to current economic and market conditions, EnerVest Operating, LLC (EnerVest) respectfully requests shut in status for this well. Last production reported in February, 2015.

In accordance with the Inactive Well Agreed Compliance Order (NMOCD - ACOI - 2016 - 001), EnerVest agrees to bring this well into compliance within 36 months following the first 15 months from date of last production by either: restoring the well to production, causing the well to be plugged and abandoned, or placing the well in approved temporary abandonment. (May 2019).

EnerVest also agrees to perform a bradenhead test one year from the date this well became inactive, and another bradenhead test one year after the initial test.

It is EnerVest's intention to bring this well into compliance when market conditions allow necessary expenditures to be economically feasible.

Authorization to proceed with shut-in procedures following NMOCD policy was provided by David Mankiewicz, BLM Farmington Field Office, via email on May 19, 2016.
