PROCEDURE

1. Hold pre-job safety meeting. Comply with all NMOCD, BLM, and COP safety and environmental regulations.
2. Check casing, tubing, and bradenhead pressures and record them in WellView. If there is pressure on the BH, contact Wells Engineer.
- 3 Load casing with water & corrosion inhibitor, as necessary. Perform MIT (Mechanical Integrity Test) above the bridge plug at 1772' to 560 psig for 30 minutes on a 2 hour chart with 1000 lb. spring. If the test passes, SI the well. RD pump truck and MOL. If the test fails, contact the Rig Superintendent and Wells Engineer.
