Displaced plug w/127 bbls 2% KCL. Plug down @ 0939 hrs 6/26/03. No cement to surface, none planned. ND BOP, set slips and cut off casing. RD & released rig 0000 hrs 6/27/03. Will show TOC and casing PT on next report.
