BP is planning to conduct a packer leakage test on the subject well. We respectfully request that the flow period for the Dakota formation be limited to 3 hours as the formation is no longer capable of sustained production and the production facilities associated with this completion are not presently capable of handling any gas. Gas produced from the Dakota completion will be vented during the test.
